Growth of 100 EUR (share class A1-DIS)

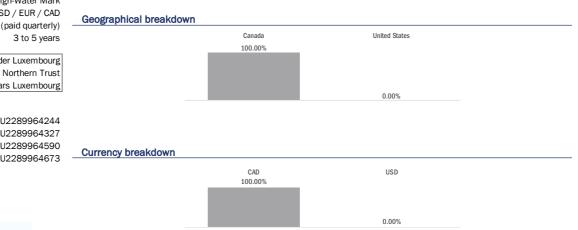
