The fund is completing its Due Diligence in 2 different new deals for potential closing.

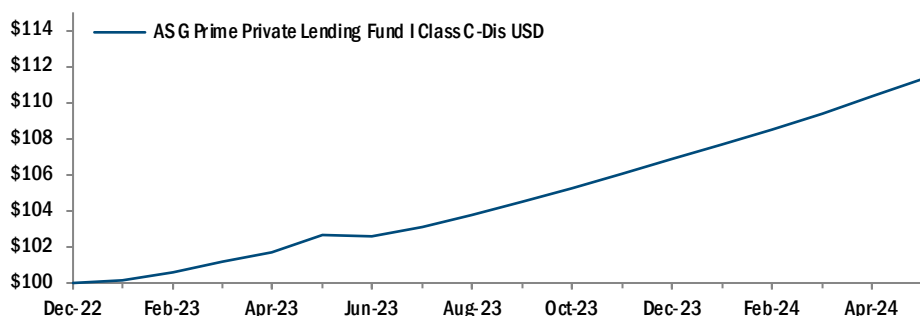
The fund is also in course to realize another exit shortly.
